# Monday, November 20, 2015 @ 12:00 PM – Board Room Minutes

## **Call to Order and Roll Call**

Dr. Hickman called to order the regular meeting of the Board of Health of the Canton City Health Department on Monday, November 20, 2015 at 12:00pm with a quorum present.

Dr. Hickman, Dr. Fiorentino, Dr. Lakritz, and Mr. Wyatt were present. Also present was Jim Adams, Christi Allen and Dr. Mader. Dr. Lakritz arrived at 12:19pm during the discussion of the Employee Discipline Policy. Miss Snell was absent.

# **Approve October 26, 2015 Board of Health Meeting Minutes**

Mr. Wyatt moved and Dr. Fiorentino seconded a motion to approve the October 26, 2015 Board of Health meeting minutes. Motion passed unanimously.

#### Approve List of Bills - \$80,548.45

Mr. Wyatt moved and Dr. Fiorentino seconded a motion to approve the list of bills totaling \$80,548.45. Motion passed unanimously.
