Position Summary:

Under general supervision of the Health Commissioner, this position is responsible for implementation of the day-to-day Stark County THRIVE infant mortality reduction project. Works with community members to examine social, economic, cultural, safety and health system factors associated with fetal and infant mortality. This position will work with the community to facilitate planning and implementation of interventions that will reduce infant mortality in Stark County. The position will report to the Health Commissioner.

Program Management. Using independent judgment and knowledge of community collaboration processes, manages the daily activities of the Stark County THRIVE program. Provides leadership to the THRIVE teams, coordinates and facilitates team meetings. Develops and maintains meeting minutes, written reports, grant proposals and other documentation pertaining to the program. Collects and reports outcome measures pursuant to established evaluation plans. Serves as the primary contact for the Stark County THRIVE program.

10% **Community Networking.** This position will serve as program liaison to the Ohio Equity Institute for Birth Outcomes (and Ohio Department of Health project to reduce infant mortality in Ohio) and other partners. Serves as primary program contact for the Stark County THRIVE collaborative.
